

### **General Updates:**

- 1. Linda Tuzzolo reported on GNR. It was a huge success.
- 2. Florida had 115 coaches in attendance and Winnebago gave \$50 to any state that had at least 50 coaches in attendance.
- 3. All chapters except Big Bend and Miracle Strip (non participation in State) received Chapters of Excellence Awards.
- 4. We received 2nd place for our Website. A big thank you goes to Phil Halstead, Webmaster.
- 5. Honorable mention went to Suncoast Winnie Gators and the Ocala Sunbirds for their newsletters
- 6. Aerial photos were sent to Suncoast RV, Lazy Days and Harberson RV

- 7. Linda also advised the committee that Paul Ragona of the Spacecoast Winnies died and a memorial of \$25 was sent to the family.
- 8. Shirley Halsted thanked club for flowers sent to her when hospital.

### **Rally Updates:**

- 1. Bruce Cheatum and Donna Wacker are working on goody bags for rally. If anyone knows company to include let them know and they will contact them. Bruce indicated that it is not hard to talk to people and get them to provide free stuff for the rally.
